GENERAL AVIATION GROWTH OPPORTUNITIES



BUSINESS JETS

EXECUTIVE SUMMARY

Saudi Arabia's General Aviation Roadmap

The General Aviation Roadmap (GAR) will significantly enhance the sector's economic impact by expanding its size, contributing to a projected SAR 7.8 billion in total sector GDP and generating over 35,000 jobs within the industry by 2030.


With a target growth of 24 business jets flights per 10,000 inhabitants, the roadmap prioritizes bolstering infrastructure, including the augmentation of terminals, hangarage capacity, and general aviation airports to improve airport connectivity.

Moreover, the framework entails fostering the growth of supply and services by increasing the number of Aircraft Operators (AOs), Fixed Base Operators (FBOs) and Maintenance, Repair, and Overhaul (MRO) players.

By strategically addressing these key target areas, the General Aviation Roadmap (GAR) is poised to propel the sector forward, stimulating economic growth and employment opportunities and establishing Saudi Arabia as a global hub for general aviation.


MAKING THE ROADMAP A REALITY

Infrastructure

Infrastructure development will provide the backbone of general aviation sector growth, with six new general aviation airports proposed as part of the roadmap.

In addition, nine general aviation terminals are planned across the Kingdom, which will also cover the two existing terminals at commercial airports, to meet projected demand for general aviation in Saudi Arabia by 2030.

The roadmap will also ensure dedicated parking hangarage capacity in key general aviation locations, which will improve attractiveness for business jet owners as well as the availability and quality of services.





Supply

Enhanced infrastructure will uplift general aviation services across the Kingdom, reducing operating costs for service providers.

In addition, Saudi Arabia will take a multi-pronged approach to encourage supply in the market, involving:

- Promoting service offering for A/C operators, FBOs and MROs across the Kingdom
- Reviewing fees and regulations

Services

A central component of the roadmap is to develop a significant MRO service within the Kingdom, enabling scale and reducing costs for FBOs.

The roadmap also targets attracting several MROs and supporting the development of local MRO capabilities in the general aviation sector.

In addition, Saudi Arabia is encouraging the development of aviation insurance, financing and leasing services within the Kingdom.

Regulations

Underpinning the roadmap is a comprehensive regulatory program led by GACA, designed to reduce barriers to entry and streamline compliance processes for general aviation companies.



Streamlined economic regulations

New economic regulations introduced by GACA in October 2023 removed the empty-leg restrictions to provide more flexibility to general aviation operators, expanding and enhancing the network connectivity to the Kingdom.

In addition, GACA streamlined licensing rules for FBOs and MROs to facilitate new market entrants.



Safety regulations

The roadmap will streamline safety standards, applying proportionate safety regulations to enable sector growth.



VAT removal

Taxation rules have also been changed to address unequal taxation for local versus foreign operators.

Enhancing digital services

GACA is also improving digitalization of processes for operators and consumers.

INVESTMENT OPPORTUNITIES

The GAR presents significant **investment opportunities** as the Kingdom works to diversify its economy and expand its tourism industry.

The projected growth of nearly **5 times the number of business jet flights per capita** will be supported by the development of a network of dedicated general aviation airports and terminals across the country.

Specifically, the development of six new general aviation airports by 2030, located in the key cities of Riyadh, Makkah, Jeddah, NEOM, Amaala, and Jubail, and nine general aviation terminals within commercial airports.

Most immediately, there will be substantial investment opportunities for infrastructure funds, airport operators, A/C operators, FBOs and MROs, which will be key to ensure the sector's development and in turn create a level playing field for investors, both locally and internationally.

Over the longer term, the ownership, operation, and management of these facilities will create openings for **airport operators**, **FBOs**, **and other aviation services**.

To facilitate this growth, the roadmap emphasizes the need for enhanced insurance and financing offerings, given the market's potential and the region's ongoing demand for business and leisure travels.

This represents an opportunity for **financial institutions, leasing firms, and specialty insurance providers** to develop innovative products and services catered to private, business, and recreational aviation clients in Saudi Arabia.

The scale of the planned infrastructure development and service expansions creates diverse and compelling investment opportunities across airport operations, A/C operations, FBOs, MROs, and ancillary services.

Pioneering investors who position themselves to capitalize on this growth can expect to reap substantial rewards in the years ahead.
