

## TEMPORARY FLIGHT AUTHORIZATION (TFA) ISSUED BASED ON A FOREIGN LICENSE (Issuance & Renewal)

**Applicability:** GACA may issue temporary flight authorization (TFA) to the holder of a foreign pilot license issued by a Contracting State to the Convention on International Civil Aviation who meets the requirements of GACAR § 61.57 and EBOOK V 9 (CHP 2 SEC.15) for performing pilot duties in aircraft of Saudi Arabian registry.

**Note:** TFA Validity. Unless suspended or revoked, 30 days from the date it was issued.
