



| Regulatory framework for the charges for GACA services

Introduction:

Based on Article 16 of the Civil Aviation Law issued by Royal Decree No 44/M dated 18/07/1426 H

which stated that:

The Authority shall undertake regulation, control, development and promotion of the air carriage sector, as well as implementation of general policies for air carriage in the Kingdom, and may to that end assume the following powers:

10- Determine fees for issuing licenses, permits, certificates and services provided by the Authority, and approve fees for aerodrome and air navigation services provided by the private sector, in accordance with the regulations” and Article 6 of statute of the General Authority of Civil Aviation issued pursuant to Council of Ministries No 33 dated 11/02/1426 H which stated that:

“The Board shall be GACA’s highest authority. It shall be in charge of the management of GACA and the conduct of its affairs as well as setting its general policy .”

It shall, in particular, assume the following powers and duties:


9- Approving rules governing licenses, services, and works provided by GACA and determining their fees, The General Authority of Civil Aviation has issued the regulatory framework for the financial charges for services provided by the Authority.

General provisions:

1. This regulatory framework aims to determine charges for issuing licenses, permits, certificates and services provided by the Authority.
2. The financial equivalent in the below table must be paid in Saudi Riyal.
3. GACA determines the method for issuing fee invoices and the payments process.
4. Any Permit, license or certificate will not be granted unless the assigned financial equivalent is settled.
5. The validity of each provided service starts from the issue date and expires according to the duration appointed in the below table.
6. This regulatory framework is the legal reference for all the services that GACA provides.
7. This regulatory framework is subject to amendments and updates if ever necessary. Hence, all amendments and updates become an integral part of the regulatory framework once approved.
