TO THE SERVICE PROVIDERS, GACA CERTIFICATE HOLDERS AND OPERATORS OF SAUDI ARABIAN REGISTERED AIRCRAFT

SUBJECT: CIVIL AVIATION SAFETY REGULATIONS OF THE GENERAL AUTHORITY OF CIVIL AVIATION OF KINGDOM OF SAUDI ARABIA

In accordance with the Civil Aviation Act of the Kingdom of Saudi Arabia (KSA) as approved by the Council of Ministers Resolution No. 185 dated 17/07/1426H and issued by the Royal Decree No. M/44 dated 18/07/1426H. (23/08/2005G), and based on the authority granted in Article 179 of the Act, the General Authority of Civil Aviation (GACA) of KSA has promulgated Civil Aviation Safety Regulations. These Regulations are issued under the authority of the President of General Authority of Civil Aviation, as a duly delegated representative of the GACA Board of Directors, in accordance with Order No.T-41, dated 30/12/1429H (28/12/2008G).

The GACA promulgated Civil Aviation Safety Regulations provide an appropriate and comprehensive framework for regulating civil aviation activities in KSA. The regulations contain definition and implementation of technical requirements and procedures in the field of civil aviation. The Standards and Recommended Practices (SARP's) contained in the International Civil Aviation Organization (ICAO) annexes and the technical information in its related documents and publications, GACA aviation safety provisions, and other regional and international civil aviation organizations form the main source in the promulgation of GACA Civil Aviation Safety Regulations.

GACA has adopted aviation safety regulations of the United States of America regarding Personnel Licensing, Aircraft Operation, Airworthiness of Aircraft, and Environmental Protection through the Title 14 of the Code of Federal Regulations (CFR) including its supporting handbooks, manuals, Advisory Circulars (ACs), Directives, policies, guidance material, Orders, Notices - as amended, to be GACA Regulations (GACAR) – Sections 1, 6, 8, and 16. The adoption of the United States aviation safety regulations for these Sections is based on GACA Board of Directors Order No. T- 4-26 and dated 28/08/1428H (10/09/2007G). These adopted regulations will be part of GACAR, taking into consideration the operational requirements of the kingdom, until GACA develops its own regulations for these areas.

Wherever a reference is indicated in the above adopted United States of America Code of Federal Regulations (CFR) to the Federal Aviation Administration (FAA), the Administrator, FAA Regional Offices or Divisions or any other organization or entity unique to the United States of America, the reference is to be substituted with the GACA Safety and Economic Regulation (S&ER) Sector, and it's Departments/Divisions responsible for the adopted regulation.
